Call 811 Before You Dig

If you plan to begin any project that involves digging — such as building a patio, putting up a fence, or planting bushes and trees — remember to call 811 at least 48 hours before before work begins.

Every digging job requires a call to 811 to have underground utility lines marked. In some cases, lines are buried close to the surface and could easily be damaged by even shallow digging. Calling 811 to request a utility locate will prevent service interruptions to your neighborhood, serious injuries, and costly repairs to underground lines. Caution – don't allow digging if utility lines aren't marked.

The Federal Communications Commission (FCC) has adopted a new compliance framework to ensure that broadband networks supported by the Connect America Fund - Broadband Loop Support (CAF-BLS) meets basic speed and latency performance standards. LPC Connect is required by the FCC to do Performance Measures Testing because we participate in the CAF-BLS.

We'll notify you if you are randomly selected for testing. The equipment used does not enable LPC Connect to see or track a customer's online activity. Only data on your internet connection's speed and latency performance is collected.

What is the FCC Affordable Connectivity Program?

Today's internet is not just a source of near-endless entertainment options, email messages, and social media connections. From providing opportunities to work from home, to receiving telehealth online from healthcare professionals, to remote learning during public health crises or emergencies, being connected to high-speed, reliable broadband internet isn't a luxury, or even a mere convenience.

High-speed broadband internet is now an integral, indispensable part of our daily lives.

And fiber internet from LPC Connect provides the dependable broadband service you and your family need to stay productive, healthy, safe, and fully interconnected to the global economy.

While we strive to price our services affordably, we understand that paying for internet can sometimes be a challenge. That's why we want to ensure all our customers are aware of a new program from the Federal Communications Commission (FCC) to assist people in getting connected to broadband: the Affordable Connectivity Program.

The FCC's Affordable Connectivity Program in a Nutshell

The Affordable Connectivity Program (the ACP) provides discounts on monthly internet bills to qualifying individuals to help purchase high-speed broadband internet service.

Established by Congress in 2021, the ACP is a nowpermanent program, replacing a similar, but temporary program launched during the height of the COVID-19 pandemic, then known as the Emergency Broadband Benefit (EBB) Program. (If you are already enrolled in that program, you can easily move into the new ACP.)

Participation in the program is based on financial need, and there are several ways to qualify for the ACP's benefits. If you qualify, enrollment is a simple, two-step process, and once completed, your discount will be automatically applied to your monthly broadband internet service bill.

The ACP's Benefits

Participants in the ACP can receive savings of up to \$30 per month for broadband service. That discount is a



significant chunk of the typical broadband monthly service cost and can put high-speed internet access within reach for many people.

Best of all, the discount comes right off your bill each month—no rebates or other action is required by you. The discount is limited to one monthly service bill per household.

Qualifications to Participate in the ACP

The ACP's benefits are available based on financial need. There are several ways to qualify for the program:

- **1.** Your income must be at or below 200% of the federal poverty guidelines;
- 2. You already qualify for and participate in programs like Medicaid, Federal Public Housing Assistance, Supplemental Nutrition Assistance Program (SNAP, commonly called Food Stamps), Federal Public Housing Assistance, SSI, WIC, or Lifeline;
- You already receive benefits under the free and reduced-price school lunch program or the school breakfast program;
- **4.** You received a Federal Pell Grant (for higher education) during the current award year.
